**TSC Members' Interventions towards Two-State Solution Support**

**DEADLINE: until 28 Feb 2026**



## BACKGROUND

In the wake of the ongoing war on Gaza following Hamas attacks against Israelis on October 7, and the watershed escalation of violence in the West Bank and E. Jerusalem, there is a new opportunity of the Israeli-Palestinian conflict returning to the top of the diplomatic agenda, especially with the launch of the Global Coalition for Advancing the Two-State Solution by the Saudi Arabia and the EU. As such, the two-state solution is regaining unprecedented momentum on the international agenda, culminating in a meeting between the High Representative of the European Union, Mr. Josep Borrell with members of the Two-State Coalition in Nicosia, Cyprus on November 23.

The PPC through a fund received from EUFPI will leverage the positive role that TSC members in Palestine can play in creating greater public and political support for the two-state solution. In doing so, the programme will pay particular attention to prioritising groups that have not played a sufficiently significant role in the MEPP thus far, such as, but not limited to, youth and women.

## OBJECTIVES OF THE INTERVENTION AND PRIORITY ISSUES

The main objective of this call for intervention is to achieve greater public and political support for the two-state solution among specific constituencies and groups in Palestine through civil society's positive engagement.

*The specific objective(s) are:*

Civil society's leverage on public discourse in support of a just and negotiated two-state solution in Palestine is fostered.

### ***Expected outcomes***

1.1 Civil society's national and transnational cooperation in favour of a just and negotiated two-state solution is fostered.

1.2 Civil society's advocacy efforts with decision makers on the policy level in favour of a just and negotiated two-state solution are enhanced.

1.3 Inter-group and intra-groups participation in dialogue on policy /advocacy issues in support of a two-state solution on the societal level is fostered, particularly with constituencies/groups who oppose or are not supportive of a just and negotiated two-state solution.

### ***Type of interventions:***

- Interventions creating a specific and measurable impact among decision makers that either promote or preserve the conditions necessary for a negotiated settlement of the conflict;
- interventions that aim at supporting participatory and inclusive civil and political engagement of women and men on both sides through, but not limited to advocacy and awareness-raising for peace-oriented policy-shaping initiatives including at the grass-roots level;
- Interventions that increase inclusive youth and women's participation in policy dialogue and peacebuilding initiatives;



- Interventions aimed at advocating for and broaden support for a negotiated two-state solution at the local or national in particular with constituencies or groups who oppose or are not favourable or supportive of a just and negotiated two-state solution;

### **SIZE OF THE GRANTS BY PPC-EUFPI**

PPC will provide two types of maximum allocation based on the institutional and organizational capacity of each TSC member organization, or external applicant which fits into the TSC membership criteria. PPC reserves the right to decide the final and actual budget for each intervention based on final evaluation of the scope, objectives and outcomes.

#### ***Track no. I***

Maximum ceiling of EUR 40,000

#### ***Track no. II***

Maximum ceiling of EUR 20,000

#### ***Pre-required Documents***

The following documents should be provided along with the intervention concept note:

- 1 – Recent certificate of registration from the competent ministry.
- 2 – VAT Exempt Certificate – updated
- 3 – Recent Board members, including signatories list issued by the competent ministry.
- 4 – Audited financial statements for the last two years (**Track no I only**)
- 5 – Financial & Administrative policies (**Track no I only**)

**Expenses of interventions to be paid on cost reimbursement basis only.**

### **RULES FOR THIS CALL FOR INTERVENTIONS**

Submission, selection and implementation of the interventions financed under this call shall be according to the current guidelines.

### ***ELIGIBILITY CRITERIA***

***Applicants:*** in order to be eligible for receiving funds should:

- be a member of the TSC
- be non-profit-making and
- be a specific type of organisation, namely non-governmental organisations. In addition, research centres, think tanks and not- for-profit media can also participate regardless whether they are current members of the TSC, but can be future members.
- be established in Palestine & registered with the Palestinian competent authorities at least 2 years in advance.

**PRIORITY WILL BE GIVEN TO ORGANIZATIONS WHICH CURRENTLY DON'T WORK ON EUFPI OR EUPi PROJECT.**



***Duration:*** The initial planned duration of an action may not be ***lower than 4 months nor exceed 9 months.***

***Sectors or themes***

Peacebuilding, conflict transformation

***Location***

Actions must take place in Palestine only (West Bank, E. Jerusalem & Gaza)

***Deadline:***

The deadlines for submitting concepts in the first round will be Nov 30, 2025. In case of receiving a large number of concepts, PPC will divide responses into two groups.

***Further Information***

Another round for receiving concepts will be until Feb 28, 2026.
